Terms and conditions

1. EOI for capacity will be considered if godown size is 5,000 MT or more.
2. The owner shall submit separate EOI for each location and site.
3. The EOI documents & other details are available on the website WWW.foodsuppb.nic.in and are also available in the office of MD, PUNGRAIN upto 10-03-2017 Till 1.00 P.M on all working days.
4. The duly completed sealed EOI in the manner prescribed shall be submitted to office of MD , PUNGRAIN, Anaaj Bhawan, Sector 39 Chandigarh at above mentioned address up to 1.00 PM till 10-03-2017 and the EOI shall be opened on the same day at 3.00 PM in the presence of godowns owners or their authorized representatives who may wish to the present.
5. Rent payable will be Rs.1.72 per quintal per month. Service Tax, if any, would be bear by the owner.
6. Under the EOI godowns would be hired for the period of one year on capacity basis. Pungrain can extend the time on yearly basis as per the requirement of Pungrain from time to time.
7. The EOI shall remain open for acceptance for 150 days from the date of opening of the EOI . However, PUNGRAIN reserve s the right to extend this period by another 90 days at its discretion, which shall be binding on the owners. Thereafter this period may be further extended by the parties on mutual consent. Any owner not keeping the offers open for the prescribed period shall be summarily rejected.
8. If the date of opening of the EOI is declared as holiday the EOI will be opened on the next working day at the same time and venue.
9. Incomplete EOI not conforming strictly in the manner prescribed offer not submitted on prescribed EOI form or late/delayed EOI shall not be considered and shall be summarily rejected.
10. The offers submitted would be governed by all the terms & conditions as laid down in the prescribe EOI Form in addition to the terms & conditions indicated herein. There would be no post tender negotiations.
11. The original copy of the EOI along with the EOI form is to be kept in one sealed envelope superscribed 'EOI for covered godowns'. The duly sealed EOI document shall be submitted to the address mentioned above.
12. PUNGRAIN reserves the right to accept or reject any or all EOI without assigning any reason/notice whatsoever and is not bound to accept EOI. PUNGRAIN also reserves the right to scrap the EOI enquiry at any stage without assigning any reason and PUNGRAIN will not be liable for any costs and consequences incurred by the owner.
